

OFF-LICENCE

Sections 17 to 20, Section 40 and Section 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012 **Redbank Estate Limited** is authorised to sell or deliver alcohol from the premises situated at **224 Te Muna Road, Martinborough**, and known as **Te Muna Valley Wines**, to any person for consumption off the premises.

ENDORSEMENT

Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

CONDITIONS

The licence is subject to the following conditions:

- 1) A remote sale of alcohol may be made at any time on any day.
- 2) The holder of this licence must ensure that any alcohol sold by remote sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00 pm on any day or before 6.00 am on the next day.
- 3) No alcohol is to be delivered from the premises on Good Friday, or Christmas Day, or before 1.00 pm on Anzac Day.
- 4) No alcohol is to be delivered from the premises at any time on Easter Sunday unless it is grape wine or fruit or vegetable wine made –
 - a) On the premises; or
 - b) From produce harvested from land on which the premises are situated.
- 5) Condition 2 applies whether the alcohol is delivered by the seller or by some other person.
- 6) The holder of this licence must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.
- 7) The licensee complies with condition 6 if they comply with regulation 14 of the Sale and Supply of Alcohol Regulations 2013 to be a reasonable procedure for that purpose.
- 8) The holder of an off-licence who sells alcohol by remote sale must comply with regulation 15 of the Sale and Supply of Alcohol Regulations 2013 requiring information to be provided by remote sellers.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 3 years commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
